**ITEM 1. CALL TO ORDER & QUORUM DETERMINATION**

**ITEM 4. REVIEW & ACTION on the November 17, 2009 Meeting Minutes.**

Commissioner Lary Etten suggested a few revisions relative to grammar and spelling. Russ acknowledged that corrections would be made in the final document. Commissioner Anita Kealey made a motion to approved the November 17, 2009 meeting minutes. Commissioner Lary Etten seconded the motion. The motion passed unanimously.

Russ Sorenson presented the commission with copies of the 2009 Annual Report Summary for their consideration and acceptance. Commissioner Lary Etten noted a few typos on page 2, for the Visual Art Wall – “In Varietate Concordia” project. Russ acknowledged that corrections would be made in the final summary report. Commissioners expressed their general appreciation and approval for the report format and project highlights, as presented. Commissioner Lary Etten made a motion to approve the 2009 Summary Report. **ITEM 6. DISCUSSION & ACTION on 2010 Work Program**

Russ Sorenson presented the commission with copies of the proposed 2010 Work Program and associated timelines for consideration and acceptance. Commissioners understood that if new calls for art, or new sculpture placements surface during the year, that the 2010 Work Program would be revised accordingly. Commissioners expressed their general appreciation and approval for the 2010 Work Program.

Commissioner Lary Etten made a motion to approve the 2010 Work Program. Commissioner Anita Kealey seconded the motion. The motion passed unanimously.

**ITEM 7. PROJECT UPDATES & ACTIONS**

a) Artistic Bicycle Racks Promotion Guide – Subcommittee Update

Russ Sorenson presented the commission with copies of the proposed promotion guide. The Commissioners expressed their appreciation and offered suggestions:

- 1) Modify cover to include photo of bicyclists on bike trail rather than an artistic design...such design is not included in the promotional guide;
- 2) Do brochure in either sepia brown tone or grey tone
- 3) Add "Artist Statement for each design;
- 4) Group Free-Form Designs together and Parking Meter Designs together;
- 5) Enlarge "High Wheeler" design;
- 6) Depict costs for each design;
- 7) Depict "fabricated metal or sheet steel." And depict "Available in stainless, enamel steel rusty steel" wording;
- 8) Depict "Abandoned Parking Meters" better on map;
- 9) Add statements on back
  - a. The parameters of the Free-Form Design Bike Rack were to be under \$2,000
  - b. The Parking Meter Design were to be under \$400
  - c. Associated costs are based on the individual artist's 2009 submittal and in 2009 dollars.
  - d. Depict city logo;
  - e. Do logo to identify that the art piece is for bicycle parking;
