a) Update on Sioux Falls Arts Council Strategic Plan
 Micah Luke explained the Sioux Falls Arts Council has approved their strategic plan. Upon
 completion, an executive summary will be provided to the Commissioners. The Arts Council
 is working on development of their website to be launch within the next few months.

Sioux Falls Arts Council is working with the SD for the Arts on a two year study that will help determine what the economic benefits of the arts are to a community. Study completion and

results are expected in 2012. Currently for every dollar spent in the arts within South Dakota there is a \$14.50 return to the economy.

 Micah Luke explained the outdoor painting by artist, Eyob, will be stored indoors so that it is
 preserved.

ITEM 6. PROJECT UPDATES & ACTIONS

a) Bike Smart Project

• Expenditures: Utilizing the grant funding from Wells Fargo Bank Green TEAM, The first bike rack purchased was "High Wheeler", by artist Paul Boerboom, at a cost of \$400. The second bike rack purchased was "Double Rim", by artist Rick Haugen, at a cost of \$250. The printing associated with the 96 BikeSmart emblems (measuring 5" X 7" in size) cost \$265. Printing associated with 100 brochures cost \$85.

It is also noted that Insight Marketing Design has provided donated creative services, including design, illustration, and overall project management for printing and fabrication for a total donation value of \$800.

Micah Luke mentioned that he needs the Bike Smart Kick-Off Celebration video file to complete the Face Book page. Russ Sorenson indicated he would inquire about it.
